Overview

The purpose of this pack is to provide guidance for skippers, operators and agents to report a voyage on the Submit a Pleasure Craft report (sPCR) web service, including steps to:

Things to know:

- Checking permission to travel is only required when reporting an arrival to the UK.
- The system will show you if a person has permission to travel or if you must check their documents.
- You can create a draft voyage plan in advance.
- Within a draft, you can add and update a person's details.
